Per Town Code Chapter 2, Article V, Division 3, Sec. 2.50.205(c)(1)**each member of Town Council shall appoint one (1) Citizen Appointee**, upon expiration of terms described in sec 2.50.205(c)(4):

Citizen Appointees shall serve four-year terms which shall expire on a staggered basis such that every year one term shall expire, except that once every four years two terms shall expire. The term of each Citizen Appointee shall commence on the first day of January (or as soon as practicable after the effective date of this Division for initial Citizen Appointees) and shall expire on the thirty-first day of the fourth successive December.

The **application deadline is 4:00 p.m. Friday, January 27, 2023**. Applications received after the deadline will be held for the next recruitment. This Finance Commissioner appointment will be made by Council Member Rennie. He will determine the applicants he wishes to interview and the timing of any interviews. The appointment will be made per Town Code 2.50.205(c)(1) and will be announced at the **February 7, 2023**, Town Council Meeting.
